## Information on the processing of personal data for contact form users

The controller hereby informs the users of the contact form as data subjects pursuant to Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) about the processing of personal data in connection with the provision of personal data in the context of contacting the controller via the form located on the website.

If the data subject has any questions concerning the processing of his or her personal data, he or she may contact the controller by post at the address of the controller's registered office or by e-mail to the above address.

### **Purpose of processing and legal basis for processing:**

The purpose of processing personal data obtained through the completed contact form is to contact and process the interested party's request, to provide further information about the company's products or services.

The legal basis is Article 6(1)(a) of GDPR – **the consent of the data subject.**

### **Scope of personal data processed:**

The controller processes personal data only to the extent necessary: name and surname, telephone number and e-mail address.

### **Identification of beneficiaries, categories of beneficiaries:**

The personal data of the data subject may be disclosed, to the extent necessary, to authorised employees of UNIMONT - VMS, an IT service provider.

### **Personal data retention period:**

The controller processes personal data for the period of processing your request, but no more than 30 days from the date of its processing. We will then destroy the personal data without undue delay.

### **Transfer of personal data to a third country/international organisation:**

Transfer to third countries or international organisations is not carried out.

## **Profiling:**

The controller does not process personal data by profiling or in a similar way based on automated individual decision-making.

## **Data subject rights**

The data subject has

- the right to request access to personal data from the controller to access the personal data processed about him or her,
- the right to rectification of personal data,
- the right to erasure or restriction of the processing of personal data,
- the right to object to the processing of personal data,
- the right to the ineffectiveness of automated individual decision-making, including profiling,
- the right to the portability of personal data,
- the right to bring an action before a supervisory authority.

## **Information on the right to withdraw consent:**

If the controller processes personal data on the basis of consent, the data subject **has the right to withdraw his or her consent to the processing at any time**. The withdrawal of consent does not affect the lawfulness of the processing of personal data prior to its withdrawal.

## **Obligation to provide personal data:**

The provision of personal data is voluntary. If you wish the company to respond to your enquiry and subsequently contact you, we will need your data. If you do not provide it, we will not be able to contact you.
